Since the school is already functioning, as such, the management can proceed ahead for operation subject to adopt the following fire safety measures/quidelines in letter and spirit forthwith:-

01 No. of CO₂ Type fire extinguisher of 4.5 Kg capacity should be provided near main electric switch board panel in addition to already existing fire extinguishers.

All exits/entrances should be kept open and free from any obstruction for easy and safe 2. evacuation of inmates during any emergency.

All electric installations existing in the building should be concealed conduit type. 3.

Manual Operated Electric Fire Alarm System should be installed in the school premises for

alerting inmates in case of any emergency.

First Aid Fire fighting system installed in the school building should be checked periodically. 5. Staff and students should be fully trained in handling / operating of fire fighting system installed in the school building. The management shall intimate this office in writing after each quarter that the fire fighting equipments installed in the school are functioning.

All class rooms and examination halls having seating capacity for more than 45 students 6.

need to be provided with two exits.

The corridor of the building shall not be used for any kind of storage. 7.

No Hazardous material should be kept inside of the school premises (especially LPG 8. cylinder, Petrol and Diesel etc.). Any deviation found in this regard, this clearance will be treated automatically withdrawn/cancelled.

The management of the school shall be wholly and solely responsible for keeping the fire 9. fighting system in working condition 24x7 and safe evacuation of its students during any

At present school is triple storied. As such no addition / alteration should be made by the 10. school management in the existing structure without prior information from this department. Any deviation found in this regard, this clearance will be treated automatically withdrawn/

11. The department can make a surprise visit to your school at any time. During the visit if the fire fighting system (i.e. existing as well as proposed) found defunct and deviation, this

clearance issued shall be treated automatically withdrawn/cancelled.

12. This clearance shall be subject to outcome of any dispute/investigation/ enquiry/trial if any, pending before any Court of Law/investigation agency. This clearance shall not confirm any

title upon the person/company in whose favour it is issued.

The validity of this clearance shall remain in force for one year and same needs to be renewed after checking of fire fighting system installed in the school building. However, before granting permission/recognition/extension or renewal thereof, the authority concerned shall satisfy himself in terms of conditions laid down in SRO-123 of 2010, issued by Education Department with regard to physical facilities and also ensure the fire safety measures/guldelines given to the proprietor by this department are fully complied with.
